1) PROMOTION DESCRIPTION: The Cobblestone x Phoenix Suns Sweepstakes (the “Sweepstakes” or “Promotion”) starts on October 15, 2022 at 12:00:00 AM Mountain Time (“MT”) and ends on November 30, 2022 at 11:59:59 PM MT (the “Promotion Period”) which is comprised of two (2) unique Sweepstakes drawing periods (“Drawing Periods”) as further described in Rule #4 below. Sponsor’s computer will serve as the official time keeping device for the Sweepstakes.

2) ELIGIBILITY: The Promotion is open only to legal residents of the state of Arizona who at time of entry are 18 years of age or older (the “Entrant”). Employees and non-employee workers of Swire Coca-Cola, USA (the “Sponsor”), Cobblestone Auto Spa, members and agents of the Phoenix Suns, the National Basketball Association (the “NBA”), its member professional Basketball clubs, employees, directors, officers, members and their respective parent companies, related subsidiaries and affiliated companies, and Marden-Kane, Inc. (the “Administrator”), and each of their respective agents, representatives, officers, directors, shareholders, and employees that are involved in the development or execution of this Sweepstakes, (collectively, the “Released Entities”), and the immediate families (spouse and parents, children and siblings, and their respective spouses regardless of where they live) and individuals living in the same households, whether related or not, of the above, are not eligible to enter or win a prize. Scan QR Code:

As part of the Sweepstakes entry process, Entrants will be required to indicate that they have read, accept, and agree to be bound by these Official Rules. By completing and submitting the required information the Entrant will receive one (1) entry into the Sweepstakes. Any entry information collected for/from the Sweepstakes shall be used only in a manner consistent with these Official Rules. When using a web-enabled mobile device, message and data rates apply. You agree to incur any and all charges demanded by your wireless carrier. Not all mobile devices offer wireless Internet access; and wireless Internet access may not be available in all areas.

Via Online Entry (without product purchase/store visitation):

To enter the Sweepstakes WITHOUT making a product purchase, store visitation or scanning a QR code go to <https://cobblestone.com/SUNS> and follow the instructions to complete and submit the online entry form (the “Online Entry”). As part of the Sweepstakes entry process, Entrants will be required to indicate that they have read, accept, and agree to be bound by these Official Rules. By completing and submitting the required information the Entrant will receive one (1) entry into the Sweepstakes. Any entry information collected for/from the Sweepstakes shall be used only in a manner consistent with these Official Rules.

Both the QR Entry and Online Entry noted above are collectively referred to as an “Entry”. **Regardless of method of Entry, there is a limit of one (1) Entry per day during the promotion period.** Proof of submitting entries will not be deemed to be proof of receipt by Sponsor. Except where prohibited by law, Entrants irrevocably grant to Sponsor, its

12) GENERAL: Any attempt by a person to use multiple e-mail to enter more than once will result in disqualification. Entries will be deemed made by the authorized account holder of the e-mail address submitted/used at time of Entry. In the event of a dispute over who submitted the winning Entry, the authorized account holder of the e-mail address attached to that winning Entry will be declared the winner.
